8. Fire Chief's Monthly Report

Chief Akre reported on many areas pertaining to SVFD daily operations:

- We are seeing a very early start to fire season in regards to weather and drought conditions.
- Nearing the end of the 60 day waiting period to start implementing the County approved Fire Impact fees. ICM David Kiff will be bringing the study to the City council for their review as soon as next week.
- The District will soon be receiving the new Type 6 for Station 4. This engine was purchased with mostly community donations.
- There will be a small 4th of July celebration this year, with a fireworks display and a car cruise. This year the cruise was approved to circle the plaza.
- Station 5 project has not received any bid interest from possible contractors. BC Lacy completed his research as to the potential FEMA grant. Grant guidelines will not allow for any work or expenditures to occur prior to acceptance of the grant.
- There has been no contact from the Derickson family as to the next steps regarding Station 6. Chief Akre recommended that Director Atkinson make contact with the family again.
- The fire prevention fee study is underway with a meeting schedule next week with the consultant to go over current fees in place.

- Weed Abatement inspections of known properties in the District have begun and notices are slated to go out next week to those properties not in compliance.
- County Vegetation Management notices were mailed out this week and inspections of those properties will begin by the end of the month, which will include properties within the Maze.

Authorize sole source purchasing of the previously approved new command vehicle

Recommended Actions

Authorize sole source purchase

Executive Summary

In October of 2020, the Board approved the purchase of a new 2021 Chevrolet Tahoe from Silveira Chevrolet to be utilized for the Shift Battalion as a command vehicle. Unfortunately, Silveira Chevrolet has been unable to deliver this vehicle to the District due to a production delay of computer chips. We still do not have a reliable delivery date. Furthermore, there is no availability of Tahoe vehicles at other dealerships or through Chevrolet.

Staff has continued to monitor this situation and has discovered two opportunities to address this immediate need of an additional command vehicle. One option is to purchase a very lightly used 2021 GMC Sierra ¾ ton pickup with 3400 miles from a private party. The second option is to purchase a ½ ton Chevrolet pickup from Silveira. Staff recommends that the Board consider authorizing the Fire Chief to enter into a fair and reasonable purchase price and agreement for the ¾ ton Sierra, if the vehicle passes inspection of our District's Fire Mechanic and fleet BC, or to purchase the ½ ton pickup from Silveira if the Sierra purchase isn't possible.
