## **EXECUTIVE SUMMARY**

TO: Board of Directors

## SUBJECT: MID YEAR FINANCIAL REPORT FOR FISCAL YEAR 2015-2016

Presented for information is a snapshot of revenues and expenses at Mid-Year for the Sonoma Valley Fire and Rescue Authority (SVFRA) and the Valley of the Moon Fire District. The report is divided into two sections. Section 1 reports on the financial status of the Sonoma Valley Fire & Rescue Authority (SVFRA). Section 2 reports on the financial status of the Valley of the Moon Fire District for the period July 1, 2015 through December 31, 2015. These reports are intended to provide the public and the Board of Directors with a financial picture of the agencies for Fiscal 2015-2016 budget and are not inclusive of all transactions.

## SECTION 1. SONOMA VALLEY FIRE & RESCUE AUTHORITY (SVFRA)

**REVENUE:** The primary budgeted revenue is derived through the transfer of funds from the City of Sonoma and the District to fund operations. With 50% of the fiscal year complete, revenue is at 50% of budget.

**EXPENDITURES:** Expenditures are at 57% of budget.

This is primarily related to use of overtime for strike team events. These amounts will be reimbursed by the State. Other line items that are over budget are typically related to timing of payments (for example, dispatch services are paid in advance) or to one-time expenses/projects.

**FUND STATUS:** For SVFRA, revenues are currently trailing budget by \$614,986. This is primarily a result of costs incurred for strike team participation on wildland fire events, which are reimbursed by the State at a later date. Because participation in strike team is unknown at budget time, both the overtime expense and the reimbursement are unbudgeted.

**RECOMMENDED AMENDMENT:** Each year District Staff (via the SVFRA) participate as strike team members in wildland fire events. The costs of overtime required for this participation is reimbursed by the State of California Office of Emergency Services. Because the number of events and participation of the District staff on strike teams are unknown at the time of budget submittal, these costs are unbudgeted. Staff also recommends that appropriations for legal services and building maintenance are increased by \$5,000 each due to unanticipated costs. Because the strike team reimbursements include additional costs for overhead, these increases in expenses can be offset by the strike team revenue resulting in no net cost to the SVFRA or District. In addition, the SVFRA will be awarded \$13,000 through the California State Firefighters' Association (CSFA) Safer Grant program for reimbursement of personal protective equipment purchases with an offsetting increase in expenses for uniforms and safety equipment.

In summary staff recommends the following amendments to the SFVRA budget. This proposed amendment has no net cost impact to the District or to the City, as all increases in expenses are offset by revenue.

## SECTION 2. VALLEY OF THE MOON FIRE DISTRICT

**REVENUE:** With 50% of the fiscal year complete, revenue is at 57% of budget. This is primarily related to increase in property tax collections. In prior years, the first property tax installment had reached 53-55% of the total property tax collected in the year. Therefore, staff does not recommend making any budgetary changes based on the current amounts received.

**EXPENDITURES:** As of December 31, 2015, District Expenses are at 51% of budget. This overage is primarily related to one-time expenses, including payment of lease for the new fire engine and budgeted transfers to reserves.

### FUND STATUS:

As of December 31, 2015, VOM revenues exceed budget by \$229,273. In addition to the property tax timing addressed under Revenue above, some of this difference is related to timing of invoices for expenses as many vendors submit invoices after the month is complete.

## REORGANIZATION SIDE LETTER AGREEMENT

### BETWEEN THE SONOMA VALLEY PROFESSIONAL FIREFIGHTERS' ASSOCIATION, IAFF LOCAL 3593, AND VALLEY OF THE MOON FIRE PROTECTION DISTRICT BY RESOLUTION 20015/2016-08, ADOPTED 2/9/2016

#### January 1, 2016 through June 30, 2016

This Side Letter Agreement has been mutually agreed to and allows for changes in the current Memorandum of Understanding between the Sonoma Valley Professional Firefighters' Association, IAFF Local 3593, and Valley of the Moon Fire Protection District (District), for the period commencing on January 1, 2016 and ending June 30, 2016.

The Sonoma Valley Professional Firefighters' Association, IAFF Local #3593, have met and conferred with the District regarding reorganization, specific to the number of allocated positions within the classifications of Fire Engineer and Firefighter.

The purpose of this Side Letter is to assist in effectuating reorganization as a means of addressing two stated objectives in the current 2015-2020 Strategic Plan related to Workforce Planning, specifically addressing recruitment/retention and the reinstatement of the Training Officer position while continuously promoting harmonious labor relations between the Sonoma Valley Professional Firefighters' Association, IAFF Local 3593, and Valley of the Moon Fire Protection District.

WHEREAS reaching a negotiated agreement on labor issues related to reorganization will save both time and money as opposed to utilizing additional funding to meet aforementioned objectives; and

WHEREAS this agreement honors the principle of seniority within the Fire Engineer classification; and

WHEREAS this agreement addresses promotional opportunities within the Firefighter classification; and

WHEREAS this negotiated agreement is based on natural attrition to occur and would result in six (6) Fire Engineer positions being reclassified to Firefighter positions.

NOW, THEREFORE, the Sonoma Valley Professional Firefighters Association, IAFF Local 3593, and Valley of the Moon Fire Protection District agree as follows:

1. **Implementation:** In reaching agreement on this Side Letter, the parties agree and confirm through negotiation that the following shall occur as positions are reclassified:

## **First position:**

a. Adjust Firefighter salary schedule to reach 50% of what is needed to create a 15% differential between Firefighter and Fire Engineer.

#### Second position:

a. Adjust Firefighter salary schedule to fully reach goal of a 15% differential between Firefighter and Fire Engineer.

- b. Adjust entire salary schedule to produce 15% differentials between all ranks and 3% between steps.
- c. Hire a part-time Training Officer as an incremental step to meet current demands with an end goal of fully funding this promotable position.

### Third position:

a. Assign Fire Engineers based on seniority to non-rotating positions on two (2) staffed engines.

### Fourth through Sixth position:

- a. Assign Fire Engineer(s) based on seniority to non-rotating positions on third staffed engine.
- b. Upon reclassification of the sixth position, reinstate a permanent Training Officer.
- 2. **Allocated Positions:** Upon the completion of the aforementioned implementation, the allocated positions in subject classifications will change from fifteen (15) Fire Engineers and six (6) Firefighters to nine (9) Fire Engineers and twelve (12) Firefighter positions.
- 3. **Revised Salary Schedule:** The following Salary Schedule will amend Appendix 'A' for the following positions (salary schedule represents the full adjustment due to the second position being reclassified prior to agreement date):

Position	Step A	Step B	Step C	Step D	Step E
Firefighter	5530	5696	5867	6043	6224
Fire Engineer	6411	6603	6801	7005	7215
Fire Captain	7432	7655	7884	8121	8365

- 4. **Career Development Guide:** Management and Labor will meet and confer on revising the CDG to include the ability of the Firefighter classification to become eligible to compete in the promotional process for the position of Fire Captain. Specifically, both parties will need to agree on years of experience to be eligible.
- 5. **Training Officer Position:** Upon the sixth position being reclassified, the District will fully fund and reinstate the Training Officer position. It is also agreed that the filling of this position will occur through an internal promotional process.



SUBJECT: Addition of Rohnert Park to the REDCOM JPA

**REDCOM** Members,

The REDCOM Board of Directors recently discussed the possiblily of the City of Rohnert Park Department of Public Safety fire services joining the REDCOM family at the January 14<sup>th</sup>, 2016 Board meeting. Although Rohnert Park has not officially requested membership, the REDCOM Board discussed the positive benefits to the JPA and to the citizens of Sonoma County.

Pursuent to the REDCOM Joint Powers Authority Agreement, Article 17. (2007), membership into the REDCOM JPA shall be open to, "...all cities, independent districts, and other public agencies which have a primary service jurisdiction for fire protection and/or ambualnce services in Sonoma County." Additionally, "...the Board of Directors has the authority to admit new members to the Authority, after notice to existing members and an opportunity for them to be heard at a public meeting. The board may set the terms and conditions for admitting new members that it deems appropriate."

Please consider this letter as your notice of our intent to further discuss and take action regarding Rohnert Park's potential membership into the REDCOM JPA, if/when Rohnert Park files an official membership request with the Board. Opportunity for members to be heard on the topic will be held at upcoming REDCOM Board of Directors meetings. We anticipate offical Rohnert Park membership action will be discussed and voted on at the February 11<sup>th</sup> or March 10<sup>th</sup>, 2016 Board of Directors meeting.
