Approve Participation in Shared Services Agreement with Glen Ellen FPD and Kenwood FPD for Extractor Purchase

#### **Executive Summary**

Glen Ellen Fire Protection District and Kenwood Fire Protection District have initiated a shared services agreement with Sonoma Valley Fire & Rescue Authority for the joint purchase of an extractor, to be installed at SVFRA Station 3. The estimated cost is \$24,000, which will be evenly divided between the named parties. The cost of approximately \$8,000 will be charged to the Valley of the Moon Fire District budget for FY 2015/16, using account no. 799 68900 703 70703. Staff is requesting approval of participation in the agreement in advance of the final budget, which will come before Board at the regular meeting in September.

### Shared Services Agreement #1



- 1. <u>Goal of Shared Services</u>. The Sonoma Valley Fire & Rescue Authority (SVFRA), the Glen Ellen Fire Protection District (GEFPD), and the Kenwood Fire Protection District (KFPD) (collectively the "parties") believe it is in the best interests of the citizens they serve and the communities they protect to identify opportunities to collaborate with shared services agreements.
- 2. <u>Purchase and Installation Costs for Shared Washer/Extractor</u>. This Agreement provides the terms and conditions for the parties' purchase, usage and maintenance of the jointly purchased washer/extractor. The washer/extractor purchase and associated construction costs for installation at the SVFRA Station #3, 1 West Agua Caliente Rd. Sonoma, CA 95476, will be evenly divided between the parties.
- 3. <u>Maintenance Costs.</u> The washer/extractor will require annual maintenance. Allocation of maintenance, detergent and other operational costs of the unit will be divided between and paid on an annual basis by the parties as follows: SVFRA 50%; GEFPD 25%; and KFPD 25%.
- 4. <u>Use and Access</u>. The unit will be used only for appropriate items owned by the parties and their assigned personnel (i.e. turnout gear, C-spine straps, uniform items contaminated in the course of an incident). Personal items will not be washed in this unit. GEFPD and KFPD personnel will have access to and usage of the washer/extractor unit seven (7) days a week, between 0730 and 1930 hours. A log will kept to track usage by each party.
- 5. <u>Mutual Indemnification</u>. The parties shall not be liable, and each party shall defend, indemnify and hold harmless each of the other parties, and each of the other parties' respective officers, agents, employees, consultants, contractors, and volunteers (collectively the "party's personnel") from and against any and all losses, claims, damages, penalties, liabilities, response costs and expenses (including reasonable fees of attorneys of such indemnitee's choice), arising out of damage or injury to persons or property due to any act or omission of any party or the party's personnel, except for those caused by the gross negligence or willful misconduct of the offending party or the offending party's personnel. The parties intend that this mutual indemnification provision shall be broadly construed and shall survive termination of this Agreement.

- 6. <u>Liability and Property Insurance</u>. Each party shall submit to each other party an endorsement evidencing liability and property insurance coverage under this Agreement as an additional named insured. Any insurance maintained by the parties may be maintained under a self-insurance or pooled risk program.
- 7. <u>Agreement Binding</u>. This Agreement shall be binding upon and shall inure to the benefit of the parties and their respective heirs, legal representatives, successors and assigns.
- 8. <u>Review</u>. This agreement will be reviewed by the parties every 5 years, starting in July of 2020.
