SPECIAL BOARD OF DIRECTORS MEETING MINUTES July 26, 2018

President Norton called the meeting to order at 2:09 p.m.

The Board held a public hearing for the purpose of considering the adoption of a resolution calling for a special election for Tuesday, November 6, 2018, on an ordinance authorizing the District to impose and levy a special tax to assist the District in meeting the current and future costs of continuing to provide authorized fire and emergency services; and exercising other rights and powers of the district; increasing the District's appropriations limit for the maximum period allowed by law to allow the use of the proceeds of the special tax; and requesting that the election be consolidated with any other election held on the same date in the same territory.

Attorney for the District Bill Adams delivered information on the fire tax and reviewed the accompanying resolution and ordinance with the Board.
