In accordance with the provisions of California Elections Code section 15620 et seq., I, William Norton, President of the Board of Directors of the Valley of the Moon Fire Protection District, authorizing governing body for the Measure Y Valley of the Moon Fire Protection District Parcel Tax voted upon at the general election held on November 6, 2018, hereby request a recount of all ballots cast for Measure Y from all precincts voting for Measure Y.

In accordance with the provisions of California Elections Code section 15630, I request that all ballots, whether voted or not, including but not limited to, as inclusively as possible, all ballot envelopes, provisional ballots, and any other relevant material concerning Measure Y, be examined as part of this recount.

In accordance with the provisions of California Elections Code section 15624, once you notify me of the estimated costs, I understand that the "Yes on Measure Y" campaign committee will make the deposit to cover the cost of this recount.

Finally, once you notify me of when the recount will commence, I will identify to you such persons who will be present on behalf of the District to observe the recount and present applicable challenges to any ballot for incompleteness, ambiguity, or other defects, in accordance with the provisions of California Elections Code section 15631.
